A Resolution confirming an award by the Board of Control of Change Order No. 1 to a professional service contract with Tri-County Jobs for Ohio's Graduates, for Comprehensive Case Management and Employment services, for the period 7/1/18 through 6/30/19, in an amount not to exceed \$200,000.00 (a cumulative increase of 33.33%), for a total amount not to exceed \$1,050,000.00, for the Executive's Department of Job and Family Services, and declaring an emergency.

WHEREAS, County Council previously adopted Resolution No. 2018-257, which confirmed an award by the Board of Control of professional service contracts between certain providers and the County's Department of Job and Family Services and the Summit and Medina Workforce Area Council of Governments to provide in-school and out-of-school youth employment and educational services under the Comprehensive Case Management and Employment Program, for the period 7/1/18 to 6/30/19, with two options to renew, in a total amount not to exceed \$2,275,000.00; and

WHEREAS, the Board of Control, at its meeting held April 10, 2019, awarded Change Order No. 1 to a professional service contract with one of the providers, Tri-County Jobs for Ohio's Graduates, for comprehensive case management and employment services for the period 7/1/18 through 6/30/19, in an amount not to exceed \$200,000.00 (a cumulative increase of 33.33%), for a total amount not to exceed \$1,050,000.00, subject to confirmation by County Council; and

WHEREAS, this Council finds and determines after reviewing all pertinent information, that the aforementioned Change Order No. 1 to said professional service contract with Tri-County Jobs for Ohio's Graduates is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The award by the Board of Control of Change Order No. 1 to a professional service contract with Tri-County Jobs for Ohio's Graduates, for Comprehensive Case Management and Employment services, for the period 7/1/18 through 6/30/19, in an amount not to exceed \$200,000.00 (a cumulative increase of 33.33%), for a total amount not to exceed \$1,050,000.00, is hereby confirmed and the County Executive is hereby authorized to execute such change order and any other necessary related documents, including, but not limited to, any necessary amendments to the professional service contract.
