7 **A Resolution authorizing the County Executive to execute an intergovernmental agreement**  
8 **with the Summit County Developmental Disabilities Board for Summer Youth**  
9 **Employment Program monitoring services, work readiness skills training, and other**  
10 **additional services, for the period 5/1/19 through 9/30/19, in an amount not to exceed**  
11 **\$180,000.00, for the Executive’s Department of Job and Family Services, and declaring an**  
12 **emergency.**

14 WHEREAS, the County of Summit and the Summit County Developmental Disabilities  
15 Board (“DD Board”) wish to enter into an intergovernmental agreement for Summer Youth  
16 Employment Program monitoring services, work readiness skills training, and other additional  
17 services, for the period 5/1/19 through 9/30/19, in an amount not to exceed \$180,000.00; and

19 WHEREAS, pursuant to Section 177.21 of the Codified Ordinances of the County of  
20 Summit, only the approval of County Council is required for intergovernmental agreements; and

22 WHEREAS, this Council finds and determines after reviewing all pertinent information  
23 that the aforementioned intergovernmental agreement with the DD Board for SYEP monitoring  
24 services is necessary and in the best interest of the County of Summit;

26 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
27 of Ohio, that:

29 SECTION 1

31 The County Executive is hereby authorized to execute an intergovernmental agreement  
32 with the Summit County Developmental Disabilities Board (“DD Board”) for Summer Youth  
33 Employment Program monitoring services, work readiness skills training, and other additional  
34 services, for the period 5/1/19 through 9/30/19, in an amount not to exceed \$180,000.00.

38 This Resolution is hereby declared an emergency in the interest of the health, safety and  
39 welfare of the residents of the County of Summit, and for the further reason to immediately  
40 provide for SYEP monitoring services, work readiness skills training and other additional  
41 services to be provided by the DD Board effective 5/1/19.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take  
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
47 effect and be in force at the earliest time provided by law.
