7 **A Resolution authorizing the County Executive to advertise for bids for drop-in childcare**
8 **services at the OhioMeansJobs Summit County Facility, for an estimated total cost not to**
9 **exceed \$75,000.00, with two annual renewal options, for the Executive's Department of Job**
10 **and Family Services, and declaring an emergency.**

12 WHEREAS, the County Executive wishes to advertise for bids for drop-in childcare
13 services at the OhioMeansJobs Summit County Facility, for an estimated total cost not to exceed
14 \$75,000.00, with two annual renewal options; and

16 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
17 requires this Council's authorization for the County to advertise for bids for contracts in excess
18 of \$50,000.00; and

20 WHEREAS, a copy of the specifications is on file with the Clerk of Council; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that it is necessary, and in the best interest of the County of Summit to authorize the County
24 Executive to advertise for bids for drop-in childcare services at the OhioMeansJobs Summit
25 County Facility, for an estimated total cost not to exceed \$75,000.00, with two annual renewal
26 options;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
29 of Ohio, that:

33 The County Executive is hereby authorized to advertise for bids drop-in childcare
34 services at the OhioMeansJobs Summit County Facility, for an estimated total cost not to exceed
35 \$75,000.00, with two annual renewal options.

39 This Resolution is declared an emergency in the interest of the health, safety and welfare
40 of the residents of the County of Summit, and for the further reason to immediately advertise for
41 bids for the aforementioned drop-in childcare services so that the necessary services may be
42 provided in a timely manner.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
48 effect and be in force at the earliest time provided by law.


