11 WHEREAS, the Prosecutor wishes to grant salary adjustments for classified non-
12 bargaining employees Kelsey Dennis and Lindsay Knight effective retroactively to April 1,
13 2019; and

15 WHEREAS, because salary adjustments for the aforementioned employees represent pay
16 increases under Section 169.07 of the Codified Ordinances of the County of Summit, County
17 Council's approval is required; and

19 WHEREAS, the Director of the Department of Human Resources will review the
20 personnel actions for the aforementioned salary adjustments as required by Section 169.07(b) of
21 the Codified Ordinances of the County of Summit; and

23 WHEREAS, the salary adjustments will be submitted to the Director of the Department
24 of Finance and Budget for the certification of availability of appropriated funds, as required by
25 Section 169.07(b) of the Codified Ordinances of the County of Summit; and

27 WHEREAS, this Council has determined, after reviewing all pertinent information, that
28 the aforementioned salary adjustments are necessary and in the best interest of the County of
29 Summit;
