7 **A Resolution authorizing the County Executive to execute a subgrant agreement with the**
8 **Ohio Department of Job and Family Services for the receipt of Title IV-E funds by the**
9 **Court of Common Pleas-Juvenile Division for State Fiscal Years 2020 and 2021, the period**
10 **from 7/1/19 through 6/30/21, in an amount estimated between \$750,000.00 and \$950,000.00**
11 **annually, with no local cash match requirement, for the Court of Common Pleas-Juvenile**
12 **Division, and declaring an emergency.**

13
14 WHEREAS, the Court of Common Pleas-Juvenile Division is a subrecipient and
15 subgrantee of funds to administer programs under Title IV-E of the Social Security Act (“Title
16 IV-E funds”), with the State of Ohio serving as the grantee and recipient of said funds from the
17 federal government; and

19 WHEREAS, as a condition of the Court of Common Pleas-Juvenile Division receiving
20 Title IV-E funds, the State of Ohio has requested that the County enter into a subgrant agreement
21 with the Ohio Department of Job and Family Services (“ODJFS”), setting forth the rights and
22 responsibilities of each party as they pertain to the receipt of Title IV-E funds, for State Fiscal
23 Years 2020 and 2021, the period from 7/1/19 through 6/30/21; and

25 WHEREAS, the Juvenile Division receives between \$750,000.00 and \$950,000.00
26 annually, with no local cash match requirement, with 25% going directly to the County General
27 Fund and the rest supporting Court salaries and programs that help those youth who are at risk
28 from being removed from the home; and

30 WHEREAS, this Council finds and determines after reviewing all pertinent information,
31 that it is necessary and in the best interest of the County to authorize the Executive to execute
32 said subgrant agreement with ODJFS for the aforementioned reasons;

34 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
35 State of Ohio, that:

39 The County Executive is hereby authorized to execute a subgrant agreement with the
40 Ohio Department of Job and Family Services for the receipt of Title IV-E funds by the Court of
41 Common Pleas-Juvenile Division for State Fiscal Years 2020 and 2021, the period from 7/1/19
42 through 6/30/21, in an amount estimated between \$750,000.00 and \$950,000.00 annually, with
43 no local cash match requirement.

47 This Resolution is hereby declared an emergency in the interest of the health, safety, and
48 welfare of the residents of the County of Summit and for the further reason of immediately
49 authorizing the execution of the subgrant agreement to ensure timely receipt of said Title IV-E
50 funds by the Juvenile Division.



16 121.22 of the Ohio Revised Code.


