7 **A Resolution, pursuant to Section 177.13 of the Codified Ordinances of the County of**  
8 **Summit, authorizing purchases by the County Executive from Rexel USA Inc., as a Best**  
9 **Practical Source, for operations within the Executive's Department of Sanitary Sewer**  
10 **Services in calendar year 2019, in a total aggregate amount not to exceed \$100,000.00, for**  
11 **the Executive's Department of Sanitary Sewer Services, and declaring an emergency.**

13 WHEREAS, Section 177.13 of the Codified Ordinances of the County of Summit  
14 requires that purchases by an officeholder exceeding \$50,000.00 in the aggregate in any calendar  
15 year, where no additional competitive quotes or bids have been taken, shall be made only upon  
16 authorization of County Council; and

17  
18 WHEREAS, the County Executive anticipates making purchases from Rexel USA Inc.,  
19 during calendar year 2019, and requests that she be authorized to make purchases as a Best  
20 Practical Source, for operations within the Executive's Department of Sanitary Sewer Services in  
21 calendar year 2019, in a total aggregate amount not to exceed \$100,000.00; and

23 WHEREAS this Council finds and determines, after reviewing all pertinent information,  
24 that it is necessary and in the best interest of the County to authorize purchases by the County  
25 Executive from Rexel USA Inc., as a Best Practical Source, for operations within the Executive's  
26 Department of Sanitary Sewer Services in calendar year 2019, in a total aggregate amount not to  
27 exceed \$100,000.00;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
30 of Ohio, that:

32 SECTION 1

34 This Council hereby authorizes purchases by the County Executive from Rexel USA Inc.,  
35 as a Best Practical Source, for operations within the Executive's Department of Sanitary Sewer  
36 Services in calendar year 2019, in a total aggregate amount not to exceed \$100,000.00.

38 SECTION 2

40 This Resolution is hereby declared an emergency in the interest of the health, safety and  
41 welfare of the residents of the County of Summit, and for the further reason to immediately  
42 authorize necessary purchases for operations within the Executive's Department of Sanitary  
43 Sewer Services in calendar year 2019.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take  
48 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
49 effect and be in force at the earliest time provided by law.

10 121.22 of the Ohio Revised Code.


