7 **A Resolution confirming an award by the Board of Control of a purchase contract with**
8 **Kenworth of Richfield, for two 2020 T470 Tandem Axle Cab Chassis dump/plow trucks, at**
9 **Sourcewell pricing, in an amount not to exceed \$234,002.00, for the Engineer, and**
10 **declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held February 20, 2019, awarded a
13 purchase contract to Kenworth of Richfield, for two 2020 T470 Tandem Axle Cab Chassis
14 dump/plow trucks, at Sourcewell pricing, in an amount not to exceed \$234,002.00, subject to
15 confirmation by County Council; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that the aforementioned purchase contract with Kenworth of Richfield is necessary and in the
19 best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

26 The award by the Board of Control of a purchase contract with Kenworth of Richfield,
27 for two 2020 T470 Tandem Axle Cab Chassis dump/plow trucks, at Sourcewell pricing, in an
28 amount not to exceed \$234,002.00, is hereby confirmed and the County Executive is hereby
29 authorized to execute such purchase contract.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the residents of Summit County, and for the further reason to immediately authorize
35 the purchase of the aforementioned necessary vehicles for the Engineer.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
47 deliberations of this Council and of any of its committees that resulted in such formal action,
