7 **A Resolution confirming an award by the Board of Control of a IV-D intergovernmental**
8 **agreement with the County Court of Common Pleas-Domestic Relations Division for**
9 **magistrate services provided relative to child support cases, for a one-year term, from**
10 **1/1/19 through 12/31/19, in an amount not to exceed \$850,000.00 for the Prosecutor-Child**
11 **Support Enforcement Agency, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting on January 30, 2019, awarded a IV-D
14 intergovernmental agreement with the County Court of Common Pleas-Domestic Relations for
15 magistrate services provided relative to child support cases for the County Prosecutor's Child
16 Support Enforcement Agency, for a one-year term, from 1/1/19 through 12/31/19, in an amount
17 not to exceed \$850,000.00; and

19 WHEREAS, this Council finds and determines after reviewing all pertinent information,
20 that the aforementioned IV-D intergovernmental agreement with the Court of Common Pleas-
21 Domestic Relations is necessary and in the best interest of the County of Summit;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

28 The award by the Board of Control of a IV-D intergovernmental agreement with the
29 County Court of Common Pleas-Domestic Relations Division for magistrate services provided
30 relative to child support cases for the County Prosecutor's Child Support Enforcement Agency,
31 for a one-year term, from 1/1/19 through 12/31/19, in an amount not to exceed \$850,000.00 is
32 hereby confirmed and the County Executive is hereby authorized to execute such
33 intergovernmental agreement.

37 This Resolution is hereby declared an emergency in the interest of the health, safety, and
38 welfare of the citizens of the County of Summit and for the further purpose of immediately
39 providing necessary magistrate services for child support cases for the Prosecutor's Child
40 Support Enforcement Agency effective 1/1/19.

45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take


