7 **A Resolution confirming an award by the Board of Control of a IV-D intergovernmental**
8 **agreement with the County Clerk of Courts for reimbursement of filing fees in child**
9 **support cases, for a one-year term, from 1/1/19 through 12/31/19, in an amount not to**
10 **exceed \$150,000.00, for the Prosecutor-Child Support Enforcement Agency, and declaring**
11 **an emergency.**

13 WHEREAS, the Board of Control, at its meeting on January 30, 2019, awarded a IV-D
14 intergovernmental agreement with the County Clerk of Courts for reimbursement of filing fees in
15 child support cases for the County Prosecutor's Child Support Enforcement Agency, for a one-
16 year term, from 1/1/19 through 12/31/19, in an amount not to exceed \$150,000.00; and

18 WHEREAS, this Council finds and determines after reviewing all pertinent information,
19 that the aforementioned IV-D intergovernmental agreement with the County Clerk of Courts is
20 necessary and in the best interest of the County of Summit;

27 The award by the Board of Control of a IV-D intergovernmental agreement with the
28 County Clerk of Courts for reimbursement of filing fees in child support cases for the County
29 Prosecutor's Child Support Enforcement Agency, for a one-year term, from 1/1/19 through
30 12/31/19, in an amount not to exceed \$150,000.00, is hereby confirmed and the County
31 Executive is hereby authorized to execute such intergovernmental agreement.

35 This Resolution is hereby declared an emergency in the interest of the health, safety, and
36 welfare of the residents of the County of Summit and for the further purpose of immediately
37 providing necessary reimbursement of filing fees in child support cases for the Prosecutor's
