7 **A Resolution authorizing the County Executive to execute an agreement with Walter J.**
8 **Walker, Jr. and Jewell G. Walker, Co-Trustees of The Walker Family Living Trust, in the**
9 **amount of \$2,920.00, to acquire an easement on their real property located at 893 Hampton**
10 **Drive, Macedonia, Ohio 44056, and known as Permanent Parcel No. 3302467, as part of the**
11 **Indian Creek Exposed Sewers Project (Q-180), located in the City of Macedonia, in Council**
12 **District 1, for the Executive's Department of Sanitary Sewer Services, and declaring an**
13 **emergency.**

15 WHEREAS, sanitary sewer easements are needed for the Indian Creek Exposed Sewers
16 Project (Q-180) ("Project"), located in the City of Macedonia, in Council District 1; and

18 WHEREAS, the County Executive desires to execute an agreement with Walter J.
19 Walker, Jr. and Jewell G. Walker, Co-Trustees of The Walker Family Living Trust, in the
20 amount of \$2,920.00, to acquire an easement on their real property located at 893 Hampton
21 Drive, Macedonia, Ohio 44056, and known as Permanent Parcel No. 3302467, as part of the
22 Project; and

24 WHEREAS, the procurement of the easement is necessary to help facilitate the
25 completion of the Project, which will allow the County to eliminate the exposed sanitary sewer
26 lines crossing Indian Creek; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that it is in the best interest of the County of Summit to authorize the County Executive to
30 execute an agreement with Walter J. Walker, Jr. and Jewell G. Walker, Co-Trustees of The
31 Walker Family Living Trust, in the amount of \$2,920.00, to acquire the aforementioned
32 easement as part of the Project;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
35 of Ohio, that;

39 The County Executive is hereby authorized to execute an agreement with Walter J.
40 Walker, Jr. and Jewell G. Walker, Co-Trustees of The Walker Family Living Trust, in the
41 amount of \$2,920.00, to acquire an easement on their real property located at 893 Hampton
42 Drive, and known as Permanent Parcel No. 3302467, in the City of Macedonia, in Council
43 District 1, as part of the Indian Creek Exposed Sewers Project (Q-180) ("Project"), and to accept
44 said easement for the County of Summit.

48 This Resolution is hereby declared an emergency in the interest of the health, safety and
49 welfare of the residents of the County of Summit and for the purpose of allowing construction of
50 the Project to proceed immediately.

8 effect and be in force at the earliest time provided by law.




