7 **A Resolution authorizing the County Executive to advertise for bids for the construction of**
8 **the Indian Creek Exposed Sewers Project Q-180 - Contract 1, located in the City of**
9 **Macedonia, in Council District 1, for an estimated total cost not to exceed \$231,996.00, for**
10 **the Executive's Department of Sanitary Sewer Services, and declaring an emergency.**

11
12 WHEREAS, the County Executive wishes to advertise for bids for the construction of
13 Indian Creek Exposed Sewers Project Q-180 – Contract 1 (“Project”), located in the City of
14 Macedonia, in Council District 1, for an estimated total cost not to exceed \$231,996.00, whereby
15 the County will line two sections of the exposed sanitary sewers that cross at Macedonia’s Indian
16 Creek; and

18 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
19 requires this Council’s authorization for the County to advertise for bids for construction
20 contracts in excess of \$50,000.00; and

22 WHEREAS, a copy of the plans and specifications for the Project are on file with the
23 Clerk of Council; and

25 WHEREAS, the County’s sanitary sewer enterprise fund will fund the Project; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
28 that it is necessary, and in the best interest of the County to authorize the County Executive to
29 advertise for bids for the construction of the aforementioned Project, for an estimated total cost
30 not to exceed \$231,996.00;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

37 The County Executive is hereby authorized to advertise for bids for the construction of
38 Indian Creek Exposed Sewers Project Q-180 - Contract 1 (“Project”), located in the City of
39 Macedonia, in Council District 1, for an estimated total cost not to exceed \$231,996.00.

41 SECTION 2

43 This Resolution is declared an emergency in the interest of the health, safety and welfare
44 of the residents of the County of Summit, and for the further reason to immediately advertise for
45 bids for the construction of the Project so that it may proceed in a timely manner.

49 Provided this Resolution receives the affirmative vote of eight members, it shall take
50 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
51 effect and be in force at the earliest time provided by law.
