7 **A Resolution confirming an award of the Board of Control of a purchase contract with**  
8 **Motorola Solutions for portable and mobile radios for communities in Ohio Homeland**  
9 **Security Region 5, in an amount not to exceed \$109,404.24, for the Executive's Department**  
10 **of Law and Risk Management – Division of Public Safety – Emergency Management**  
11 **Agency, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held January 30, 2019, awarded a  
14 purchase contract to Motorola Solutions for portable and mobile radios for communities in Ohio  
15 Homeland Security Region 5, in an amount not to exceed \$109,404.24, subject to confirmation  
16 by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
19 that the aforementioned purchase contract with Motorola Solutions is necessary and in the best  
20 interest of the County of Summit;

22 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
23 of Ohio, that:

25 SECTION 1

27 The award by the Board of Control of a purchase contract with Motorola Solutions for  
28 portable and mobile radios for communities in Ohio Homeland Security Region 5, in an amount  
29 not to exceed \$109,404.24, is hereby confirmed and the County Executive is hereby authorized  
30 to execute such purchase contract.

32 SECTION 2

34 This Resolution is hereby declared an emergency in the interest of health, safety and  
35 welfare of the residents of the County of Summit, and for the further reason to immediately  
36 purchase said radios from Motorola Solutions within the program period to further provide for  
37 the safety of the public.

39 SECTION 3

41 Provided this Resolution receives the affirmative vote of eight members, it shall take  
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
43 effect and be in force at the earliest time provided by law.

45 SECTION 4

47 It is found and determined that all formal actions of this Council concerning and relating  
48 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
49 deliberations of this Council and of any of its committees that resulted in such formal action,  
50 were in meetings open to the public, in compliance with all legal requirements, including Section  
51 121.22 of the Ohio Revised Code.


