7 **A Resolution confirming an award by the Board of Control of a purchase contract with**  
8 **Cargill, Incorporated for road salt for the 2019 snow and ice control season, under CUE**  
9 **pricing, in an amount not to exceed \$750,000.00, for the Engineer, and declaring an**  
10 **emergency.**

12 WHEREAS, the Board of Control, at its meeting held February 6, 2019, awarded a  
13 purchase contract to Cargill, Inc. for road salt for the 2019 snow and ice control season, under  
14 CUE pricing, in an amount not to exceed \$745,500.00, subject to confirmation by County  
15 Council; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
18 that the aforementioned purchase contract with Cargill Incorporated is necessary and in the best  
19 interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
22 of Ohio, that:

26 The award by the Board of Control of a purchase contract with Cargill, Incorporated for  
27 road salt for the 2019 snow and ice control season, under CUE pricing, in an amount not to  
28 exceed \$745,500.00, is hereby confirmed and the County Executive is hereby authorized to  
29 execute such purchase contract.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and  
34 welfare of the residents of Summit County, and for the further reason to immediately provide for  
35 road salt for the 2019 snow and ice control season.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take  
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
41 effect and be in force at the earliest time provided by law.

10 121.22 of the Ohio Revised Code.


