7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract with Greenleaf Family Center to provide assessments to identify individuals who**  
9 **may require enhanced Court services through the Summit County Targeted Community**  
10 **Alternatives to Prison plan, for the period 1/1/19 through 12/31/19, in an amount not to**  
11 **exceed \$131,250.00, for the Executive's Department of Law and Risk Management –**  
12 **Division of Public Safety, and declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held January 9, 2019, awarded a  
15 professional service contract with Greenleaf Family Center, to provide assessments to identify  
16 individuals who may require enhanced Court services through the Summit County Targeted  
17 Community Alternatives to Prison plan, for the period 1/1/19 through 12/31/19, in an amount not  
18 to exceed \$131,250.00, subject to confirmation by County Council; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
21 that the aforementioned professional service contract with Greenleaf Family Center is necessary  
22 and in the best interest of the County of Summit;

24 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
25 of Ohio, that:

29 The award by the Board of Control of a professional service contract with Greenleaf  
30 Family Center to provide assessments to identify individuals who may require enhanced Court  
31 services through the Summit County Targeted Community Alternatives to Prison plan, for the  
32 period 1/1/19 through 12/31/19, in an amount not to exceed \$131,250.00, is hereby confirmed  
33 and the County Executive is hereby authorized to execute such professional service contract.

37 This Resolution is hereby declared an emergency in the interest of health, safety and  
38 welfare of the residents of the County of Summit, and for the further reason to immediately  
39 continue support of the Summit County Targeted Community Alternatives to Prison plan

44 Provided this Resolution receives the affirmative vote of eight members, it shall take  
45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
