7 **A Resolution authorizing the County Executive to advertise for bids for the West Bath**
8 **Road Bridge Rehabilitation Project, located in the City of Akron, Council Districts 3 and 4,**
9 **for an estimated total cost not to exceed \$1,003,000.00 for the Engineer, and declaring an**
10 **emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
13 requires this Council's authorization for the County Executive to advertise for bids; and

14
15 WHEREAS, the County Engineer has determined there is a public need to rehabilitate the
16 West Bath Road Bridge over the Cuyahoga River, structure number AKR-048-0615, located in
17 the City of Akron, in Council Districts 3 and 4; and

18
19 WHEREAS, the Engineer estimates the total cost for design and construction to be
20 \$1,003,000.00, with all significant expenditures requiring separate Council and/or Board of
21 Control approval; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that it is necessary and in the best interest of the County of Summit to authorize the County
25 Executive to advertise for bids for the West Bath Road Bridge Rehabilitation Project;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
28 of Ohio, that:

30 SECTION 1

32 The County Executive is hereby authorized to advertise for the West Bath Road Bridge
33 Rehabilitation Project (AKR-048-0615), located in the City of Akron, in Council Districts 3 and
34 4, with an estimated cost not to exceed \$1,003,000.00.

38 This Resolution is hereby declared an emergency in the interest of the health, safety, and
39 welfare of the residents of the County of Summit, and for the further reason that it will
40 immediately allow a necessary project to enhance the safety of Summit County motorists by
41 rehabilitating a deteriorating bridge to proceed.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
47 effect and be in force at the earliest time provided by law.


