7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award of a Drugged Driving Enforcement Program Grant from the Ohio**
9 **Department of Public Safety, Ohio Traffic Safety Office, for the period 12/1/18 to 9/30/19,**
10 **in the amount of \$11,918.30 with no local cash match requirement, and appropriating said**
11 **grant funds, for the Sheriff, and declaring an emergency.**

13 WHEREAS, County Sheriff's Office has been awarded a grant, in the amount of
14 \$11,918.30, with no local cash match requirement, from the Ohio Department of Public Safety,
15 through its Ohio Traffic Safety Office ("OTSO"), for the period 12/1/18 to 9/30/19, in order to
16 operate a Drugged Driving Enforcement Program ("DDEP") in Summit County; and

18 WHEREAS, this is the first year the County Sheriff's Office has received this grant to
19 fund a DDEP in the County of Summit; and

21 WHEREAS, this Council has determined by reviewing all pertinent information that it is
22 necessary to authorize the County Executive to execute any documents necessary to accept the
23 aforementioned DDEP Grant through OTSO, and to appropriate said grant funds;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

30 The County Executive is hereby authorized to execute any documents necessary to accept
31 an award of a grant from the Ohio Department of Public Safety, Ohio Traffic Safety Office, for a
32 Drugged Driving Enforcement Program ("DDEP") in Summit County, for the period of 12/1/18
33 to 9/30/19, in the amount of \$11,918.30, with no local cash match requirement.




