7 **A Resolution appropriating funds totaling \$12,800,000.00 in order to meet projected**
8 **expenditures for the Division of COVID-19 Response for the period 3/1/2020 through**
9 **12/30/2020 and declaring the expenditures necessary due to the public health emergency**
10 **with respect to the Coronavirus Disease 2019 (COVID-19) for the Executive's Department**
11 **of Finance and Budget, and declaring an emergency.**

13 WHEREAS, Council recently adopted Ordinance No. 2020-141, amended Chapter 115 of
14 the Codified Ordinances of the County of Summit, entitled "Administrative Services
15 Organization" to temporarily establish the Division of COVID-19 Response as an administrative
16 service under the Executive for the period 3/1/2020 through 12/30/2020 and declaring the
17 creation of such Division and its expenditures expenditure necessary due to the public health
18 emergency with respect to the Coronavirus Disease 2019 (COVID-19); and

20 WHEREAS, in order to account for COVID-19 necessitated capital projects, payroll and
21 benefit costs associated with public health and public safety employees, who are deemed for
22 administrative convenience as substantially dedicated to mitigating or responding to the COVID-
23 19 public health emergency by the U.S. Treasury, and payroll and benefit costs associated with
24 public employees who could have been furloughed or otherwise laid off but who were instead
25 repurposed to perform previously unbudgeted functions substantially dedicated to mitigating or
26 responding to the COVID-19 public health emergency it is necessary for the Fiscal Officer to
27 establish fund 10190 - Coronavirus Relief Operating Fund and appropriate funds for such
28 expenditures; and

30 WHEREAS, the Division of COVID-19 Response requires the appropriation of funds in
31 the amount of \$12,800,000.00 in order to meet projected expenditures for the Division of
32 COVID-19 Response for the period 3/1/2020 through 12/30/2020; and

34 WHEREAS, This Council declares that the temporary establishment of the Division of
35 COVID-19 Response as an administrative service under the Executive for the period 3/1/2020
36 through 12/30/2020 and all expenditures and actions of the Division of COVID-19 Response are
37 necessary due to the public health emergency with respect to the Coronavirus Disease 2019
38 (COVID-19); and

40 WHEREAS, this Council has determined by reviewing all pertinent information that the
41 appropriations contained in Section 1 are immediately needed for operations of the County and
42 are necessary and in the best interest of the County of Summit;

44 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

17 (COVID-19) and is being done in compliance with the provisions of section 5001 of the federal
18 Coronavirus Aid, Relief and Economic Security Act.

22 This Resolution is hereby declared an emergency in the interest of the health, safety and
23 welfare of the residents of the County of Summit and for the further reason that these
24 appropriations immediately needed for operations of the County.

28 Provided this Resolution receives the affirmative vote of eight members, it shall take
29 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
30 effect and be in force at the earliest time provided by law.

35 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
36 deliberations of this Council and of any of its committees that resulted in such formal action,


