7 **A Resolution authorizing the County Executive to execute a Cooperative Agreement with**
8 **the City of Hudson for the Ravenna Road Resurfacing Project, located in Twinsburg**
9 **Township and the City of Hudson, in Council District 1, for the Engineer, and declaring an**
10 **emergency.**

11
12 WHEREAS, the County Engineer has secured up to \$600,000.00 in Surface
13 Transportation Block Grant funding to resurface Ravenna Road from Old Mill Road to the
14 Portage County line (the "Project"), with a 20% local cash match requirement; and

15
16 WHEREAS, Ravenna Road (County Highway 12) extends from the City of Twinsburg to
17 the Portage County line and passes through both Twinsburg Township and the City of Hudson,
18 in Council District 1; and

19
20 WHEREAS, approximately 0.61 miles of the Project is in Twinsburg Township and
21 approximately 0.75 miles of the Project is in the City of Hudson; and

22
23 WHEREAS, the Engineer will administer the project and will be responsible for local
24 cost share for the portion of the project located in Twinsburg Township and the City of Hudson
25 will be responsible for the local cost share for the portion of the Project located in the City of
26 Hudson; and

28 WHEREAS, the County of Summit and the City of Hudson will further agree to provide
29 50% each for the cost of engineering, design, and environmental documentation, which are
30 estimated to be \$115,000.00; and

32 WHEREAS, a Cooperative Agreement is needed to outline the duties and financial
33 commitments for the County of Summit and the City of Hudson, as detailed in Exhibit A; and

35 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
36 that it is necessary and in the best interest of the County of Summit to authorize the County
37 Executive to execute a Cooperative Agreement with the City of Hudson for the aforementioned
38 Project;

40 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
41 of Ohio, that;

43 SECTION 1

44
45 The County Executive is hereby authorized to execute a Cooperative Agreement with the
46 City of Hudson for the Ravenna Road Resurfacing Project, pursuant to which each entity will
47 provide the 20% local match required for the portion of the Project located within their
48 jurisdiction and 50% each for the cost of engineering, design, and environmental documentation,
49 which are estimated to be \$115,000.00. A copy of said agreement is attached hereto as Exhibit A
50 and incorporated fully herein, with such modifications and revisions as shall be in furtherance of
51 the provisions of said Cooperative Agreement and not substantially adverse to the County, all of

6 which shall be conclusively evidenced by the execution thereof by the County Executive.

10 This Resolution is hereby declared an emergency in the interest of the health, safety and
11 welfare of the residents of the County of Summit, and for the further purpose to immediately
12 allow the County to move forward with a project that is necessary for the safe and convenient
13 travel of motorists in Twinsburg Township and the City of Hudson.

17 Provided this Resolution receives the affirmative vote of eight members, it shall take
18 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
19 effect and be in force at the earliest time provided by law.

21 SECTION 4

23 It is found and determined that all formal actions of this Council concerning and relating
24 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
25 deliberations of this Council and of any of its committees that resulted in such formal action,
26 were in meetings open to the public, in compliance with all legal requirements, including Section
27 121.22 of the Ohio Revised Code.
