7 **A Resolution confirming an award by the Board of Control of a renewal (third and final) of**
8 **a professional service contract with Euthenics, Inc. to perform inspection services for the**
9 **North Main Street Bridge, located in the City of Akron, in Council District 2, for a one-**
10 **year term, from 8/1/20 through 7/31/21, in an amount not to exceed \$52,877.34, for the**
11 **Engineer, and declaring an emergency.**

13 WHEREAS, the North Main Street Bridge over the Cuyahoga River, located in the City
14 of Akron, in Council District 2, also known as the High Level Bridge, is Summit County's tallest
15 and most complex bridge; and

16
17 WHEREAS, in addition to requiring specialized condition inspection services on the
18 bridge because of its size and height, the bridge is also classified as "fracture critical" meaning
19 there is no redundancy built into the structure; and

20
21 WHEREAS, because of this classification, the County Engineer performs additional in-
22 depth inspections every two years per Federal Highway Administration and Ohio Department of
23 Transportation requirements; and

25 WHEREAS, County Council previously adopted Resolution No. 2017-119, which
26 confirmed an award by the Board of Control of a professional service contract with Euthenics,
27 Inc. for bridge condition inspection engineering services for the North Main Street Bridge, for a
28 one-year term, with three options to renew for an additional one-year term, in an amount not to
29 exceed \$59,078.25; and

31 WHEREAS, the Board of Control, at its meeting held May 20, 2020, awarded a renewal
32 (third and final) of a professional service contract with Euthenics, Inc. to perform inspection
33 services for the North Main Street Bridge, for a one-year term, from 8/1/20 through 7/31/21, in
34 an amount not to exceed \$52,877.34, subject to confirmation by County Council; and

36 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
37 that the aforementioned renewal (third and final) of the professional service contract with
38 Euthenics, Inc. is necessary and in the best interest of the County of Summit;

40 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
41 of Ohio, that:

45 The award by the Board of Control of a renewal (third and final) of a professional
46 service contract with Euthenics, Inc. to perform inspection services for the North Main Street
47 Bridge, located in the City of Akron, in Council District 2, for a one-year term, from 8/1/20
48 through 7/31/21, in an amount not to exceed \$52,877.34, is hereby confirmed and the County
49 Executive is hereby authorized to execute such professional service contract and any other
50 necessary related documents.
