7 **A Resolution confirming an award by the Board of Control of Change Order No. 3 to a**
8 **professional service contract with Mann Parsons Gray Architects, Inc., for professional**
9 **design services, in an amount not to exceed \$15,000.00 (for a cumulative increase of**
10 **87.50%), for a total amount not to exceed \$75,000.00, for the Executive's Department of**
11 **Administrative Services – Physical Plants, and declaring an emergency.**

13 WHEREAS, due to a larger than normal volume of design projects, including the
14 Consolidated Dispatch Center Project, Ohio Building Vault and the HVAC project for Summit
15 County Children's Services, it is necessary to approve Change Order No. 3 to the County's
16 professional service contract with Mann Parsons Gray Architects, Inc. for professional design
17 services; and

19 WHEREAS, the Board of Control, at its May 6, 2020 meeting, awarded Change Order
20 No. 3 to a professional service contract with Mann Parsons Gray Architects, Inc., for
21 professional design services, in an amount not to exceed \$15,000.00 (for a cumulative increase
22 of 87.5%), for a total amount not to exceed \$75,000.00; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that Change Order No. 3 to the professional service contract with Mann Parsons Gray Architects,
26 is necessary and in the best interest of the County of Summit;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
29 of Ohio, that:

33 Change Order No. 3 to a professional service contract with Mann Parsons Gray
34 Architects, Inc., for a miscellaneous design contract, in an amount not to exceed \$15,000.00 (for
35 a cumulative increase of 87.50%), for a total amount not to exceed \$75,000.00, is hereby
36 confirmed and the County Executive is hereby authorized to execute such change order and any
37 other necessary related documents.

41 This Resolution is declared an emergency in the interest of the health, safety and welfare
42 of the residents of the County of Summit and for the further reason to immediately confirm the
43 award of a necessary change order to the aforementioned professional service contract so that the
44 projects are able to be completed in a timely manner.

48 Provided this Resolution receives the affirmative vote of eight members, it shall take
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
50 effect and be in force at the earliest time provided by law.


