7 **A Resolution authorizing the County Executive to pay Christine Tartamella the sum of**
8 **\$21,067.52 for cleanup and restoration costs resulting from a sanitary sewer backup at her**
9 **residence located at 4004 Pardee Road, Stow, Ohio 44224, in Council District 3, and to**
10 **prepare and execute a release of claims and any other necessary related documents, for the**
11 **County Executive's Department of Sanitary Sewer Services, and declaring an emergency.**

13 WHEREAS, on March 28, 2020, Christine Tartamella filed a sewer backup cleaning and
14 sanitation claim (the "Claim") with the County's Department of Sanitary Sewer Services
15 ("DSSS"), therein seeking reimbursement for cleanup and restoration costs resulting from a
16 sanitary sewer backup at her residence located at 4004 Pardee Road, Stow, Ohio 44224, in
17 Council District 3; and

19 WHEREAS, in accordance with Chapter 119A of the Codified Ordinances of the County
20 of Summit, DSSS examined the evidence surrounding the Claim, assessed the damages sustained
21 to Ms. Tartamella's residence, and valued the total cost of repairs and clean up to be an amount
22 not to exceed \$21,067.52; and

24 WHEREAS, the County Executive desires to pay Christine Tartamella an amount not to
25 exceed \$21,067.52 to settle the Claim and to prepare and execute a release of claims and any
26 other necessary related documents; and

28 WHEREAS, Chapter 119A of the Summit County Codified Ordinances requires this
29 Council's authorization for the County Executive to pay all sewer backup cleaning and sanitation
30 claims that exceed ten thousand dollars (\$10,000.00); and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
33 that it is necessary and in the best interest of the County of Summit to authorize the County
34 Executive to pay the sum of \$21,067.54 to Christine Tartamella for the Claim and to prepare and
35 execute a release of claims and any other necessary related documents;

37 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
38 of Ohio, that:

40 SECTION 1

42 The County Executive is hereby authorized to pay to Christine Tartamella the sum of
43 \$21,067.52 to reimburse her for the cleanup and restoration of her residence located at 4004
44 Pardee Road, Stow, Ohio 44224, in Council District 3, as a result of the sanitary sewer backup
45 that occurred on March 28, 2020. The County Executive is further authorized to prepare and
46 execute a release of claims and any other necessary documents related to this claim.

50 This Resolution is declared an emergency in the interest of the health, safety and welfare
51 of the residents of the County of Summit, and for the further reason to immediately authorize the
52 County Executive to make payment for a sanitary sewer backup claim within a timely fashion.




