7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Kronos, Inc., as a Sole Source, to migrate the County's time-tracking Kronos**
9 **Software as a Service applications to the Kronos Workforce Dimensions Software as a**
10 **Service applications, for a three-year term, in an amount not to exceed \$526,068.00, for the**
11 **Office of Information Technology, and declaring an emergency.**

13 WHEREAS, Kronos, Inc. implemented the County's time-tracking system and is a Sole
14 Source for the software and services for that system; and

15
16 WHEREAS, the Office of Information Technology recommends that the County enter a
17 professional service contract with Kronos, Inc., as a Sole Source, to migrate the County's Kronos
18 Software as a Service ("SAS") applications for the County's time-tracking system to the Kronos
19 Workforce Dimensions ("SAS") applications, for a three-year term, for services in an amount not
20 to exceed \$24,228.00, and an amount not to exceed \$13,940.00 per month for the Kronos
21 Workforce Dimensions SAS applications, for \$501,840.00 total, for a total amount not to exceed
22 \$526,068.00; and

24 WHEREAS, the IT Board, at its meeting held June 11, 2020, approved said professional
25 service contract with Kronos, Inc. and

27 WHEREAS, the Board of Control, at its meeting held June 10, 2020, awarded said
28 professional service contract with Kronos, Inc., subject to confirmation by County Council; and

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
31 that aforementioned professional service contract with Kronos, Inc. is necessary and in the best
32 interest of the County of Summit;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
35 of Ohio, that;

39 The award by the Board of Control a professional service contract with Kronos, Inc., as a
40 Sole Source, to migrate the County's Kronos Software as a Service ("SAS") applications for the
41 County's time-tracking system to the Kronos Workforce Dimensions ("SAS") applications, for a
42 three-year term, for services in an amount not to exceed \$24,228.00, and an amount not to
43 exceed \$13,940.00 per month for the Kronos Workforce Dimensions SAS applications, for
44 \$501,840.00 total, for a total amount not to exceed \$526,068.00, is hereby confirmed and the
45 County Executive is hereby authorized to execute such professional service contract and any
46 other necessary related documents.

15 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
16 effect and be in force at the earliest time provided by law.
