7 **A Resolution confirming an award by the Board of Control of professional service**
8 **contracts with certain providers for State Fiscal Year 2021 Title XX funded services and**
9 **Temporary Assistance to Needy Families funded services, from 7/1/20 through 6/30/21, and**
10 **from 10/1/20 through 9/30/21, in a total amount not to exceed \$500,000.00, for the County**
11 **Executive's Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held June 10, 2020, awarded
14 professional service contracts with certain providers for State Fiscal Year 2021 of Title XX
15 funded services and Temporary Assistance to Needy Families ("TANF") funded services, from
16 7/1/20 through 6/30/21, and from 10/1/20 through 9/30/21, in a total amount not to exceed
17 \$500,000.00, subject to confirmation by County Council, a list of which is set forth in Exhibit A,
18 attached to this Resolution and incorporated herein by reference; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information
21 that the aforementioned professional service contracts with certain providers set forth in Exhibit
22 A are necessary and in the best interest of the County of Summit;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
25 of Ohio, that:

29 The award by the Board of Control of professional service contracts with certain
30 providers, as set forth in Exhibit A, attached to this Resolution and incorporated herein by
31 reference, for the State Fiscal Year 2021 of Title XX funded services and Temporary Assistance
32 to Needy Families ("TANF") funded services, from 7/1/20 through 6/30/21, and from 10/1/20
33 through 9/30/21, in a total amount not to exceed \$500,000.00, are hereby confirmed and the
34 County Executive is hereby authorized to execute such professional service contracts and any
35 other necessary related documents.

39 This Resolution is hereby declared an emergency in the interest of the health, safety and
40 welfare of the residents of the County of Summit, and for the further reason to immediately
41 approve the aforementioned professional service contracts in order to enable to providers to
42 provide necessary services as expeditiously as possible.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take
47 effect immediately upon its adoption and approval by the County Executive; otherwise, it shall
48 take effect and be in force at the earliest time provided by law.




