7 **A Resolution confirming an award by the Board of Control of a renewal (first of two) of a**
8 **purchase contract with Waste Management of Ohio, Inc., for trash removal and disposal at**
9 **various County facilities, for a two-year term, from 6/1/20 through 5/31/22, in an amount**
10 **not to exceed \$132,000.00, for the County Executive's Department of Finance and Budget-**
11 **Division of Purchasing, and declaring an emergency.**

13 WHEREAS, County Council previously adopted Resolution No. 2018-205, which
14 confirmed the award by the Board of Control of a two-year purchase contract with Waste
15 Management of Ohio, Inc., with two options to renew for an additional two year term, for trash
16 removal and disposal at various County facilities, in an amount not to exceed \$128,137.68; and

18 WHEREAS, the Board of Control, at its meeting held June 10, 2020, awarded a renewal
19 (first of two) of the aforementioned purchase contract with Waste Management of Ohio, Inc., for
20 a two-year term, from 6/1/20 through 5/31/22, in an amount not to exceed \$132,000.00, subject
21 to confirmation by County Council; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that the aforementioned renewal (first of two) of a purchase contract with Waste Management of
25 Ohio, Inc., is necessary and in the best interest of the County of Summit;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
28 of Ohio, that:

32 The award by the Board of Control of a renewal (first of two) of a purchase contract with
33 Waste Management of Ohio, Inc., for trash removal and disposal at various County facilities, for
34 a two-year term, from 6/1/20 through 5/31/22, in an amount not to exceed \$132,000.00, is hereby
35 confirmed and the County Executive is hereby authorized to execute such purchase contract and
36 any other necessary related documents.

40 This Resolution is hereby declared an emergency in the interest of the health, safety and
41 welfare of the residents of the County of Summit, and for the further reason to immediately
42 provide for continued trash removal and disposal services.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take
47 effect immediately upon its adoption and approval by the County Executive; otherwise, it shall
48 take effect and be in force at the earliest time provided by law.
