7 **A Resolution authorizing the County Executive to pay Jill and Thomas Buckeye the sum of**
8 **\$21,414.02 for cleanup and restoration costs resulting from a sanitary sewer backup at**
9 **their residence located at 10154 Regatta Trail, Aurora, Ohio 44202, in Council District 1,**
10 **and to prepare and execute a full and final release of claims and any other necessary**
11 **related documents, for the County Executive's Department of Sanitary Sewer Services, and**
12 **declaring an emergency.**

13
14 WHEREAS, on March 19, 2020, Jill and Thomas Buckeye filed a sewer backup cleaning
15 and sanitation claim (the "Claim") with the County's Department of Sanitary Sewer Services
16 ("DSSS"), therein seeking reimbursement for cleanup and restoration costs resulting from a
17 sanitary sewer backup at their residence located at 10154 Regatta Trail, Aurora, Ohio 44202, in
18 Council District 1; and

20 WHEREAS, in accordance with Chapter 119A of the Codified Ordinances of the County
21 of Summit, DSSS examined the evidence surrounding the Claim, assessed the damages sustained
22 to the Buckeyes' residence, and valued the total cost of repairs at an amount not to exceed
23 \$21,414.02; and

25 WHEREAS, the County Executive desires to pay Jill and Thomas Buckeye an amount
26 not to exceed \$21,414.02 to settle the Claim and to prepare and execute a full and final release of
27 claims and any other necessary related documents; and

29 WHEREAS, Chapter 119A requires this Council's authorization for the County
30 Executive to pay all sewer backup cleaning and sanitation claims that exceed ten thousand
31 dollars (\$10,000.00); and

33 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
34 that it is necessary and in the best interest of the County of Summit to authorize the County
35 Executive to pay the sum of \$21,414.02 to Jill and Thomas Buckeye for the Claim and to prepare
36 and execute a release and any other necessary related documents;

38 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
39 of Ohio, that:

41 SECTION 1

43 The County Executive is hereby authorized to pay to Jill and Thomas Buckeye the sum of
44 \$21,414.02 to reimburse them for the cleanup and restoration of their residence located at 10154
45 Regatta Trail, Aurora, Ohio 44202, in Council District 1, as a result of the sanitary sewer backup
46 that occurred on March 19, 2020. The Executive is further authorized to prepare and execute a
47 full and final release of claims and any other necessary documents related to this claim.



22 121.22 of the Ohio Revised Code.


