7 **A Resolution, pursuant to Section 169.04(i) of the Codified Ordinances of the County of**
8 **Summit, entitled "Temporary Hiring Freeze," to authorize the County Executive to hire a**
9 **Residential Building Official, for the County Executive, and declaring an emergency.**

10
11 WHEREAS, this Council previously adopted Ordinance No. 2020-095, which enacted
12 Section 169.04(i) of the Codified Ordinances of the County of Summit, entitled, "Temporary
13 Hiring Freeze," due to the anticipated economic crisis and related budgetary concerns resulting
14 from the COVID-19 pandemic and the State of Ohio's Stay at Home Order; and

15
16 WHEREAS, Section 169.04(i) provides that if a County office is able to demonstrate that
17 the filling of an existing position by hiring an employee is necessary for the effective and
18 continued operation of the office, Council may adopt a Resolution authorizing the office to hire
19 said employees; and

20
21 WHEREAS, the current Residential Plans Examiner is being moved to a bargaining unit
22 position of Building Inspector, leaving the Residential Plans Examiner position vacant; and

23
24 WHEREAS, on 6/18/20, the Human Resource Commission issued Order No. 20-01,
25 which adopted the revisions and upgrade of the classification of Residential Plans Examiner,
26 Category 3, Grade 5, Class Code 35061 to the classification of Residential Building Official,
27 Category 3, Grade 6, Class Code 35061; and

29 WHEREAS, it is necessary for the County Executive to fill the vacated Residential
30 Building Official position in order for the Division of Building Standards to operate efficiently;
31 and

33 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
34 that it is necessary and in the best interest of the County of Summit to authorize the County
35 Executive to hire a new Residential Building Official;

37 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
38 State of Ohio, that:

42 County Council hereby determines that the County Executive has demonstrated that it is
43 necessary for the effective and continued operation of the Division of Building Standards to
44 authorize, pursuant to Section 169.04(i) of the Codified Ordinances, the hiring of a new
45 Residential Building Official, Category 3, Grade 6, Class Code 35061.

49 This Resolution is hereby declared an emergency in the interest of the health, safety and
50 welfare of the residents of the County of Summit and for the further reason to immediately
51 authorize the County Executive to hire a new Residential Building Official for the efficient
52 operation of the Division of Building Standards.


