A Resolution confirming the award by the Board of Control of a construction contract with Krumroy-Cozad Construction, Inc. for the Summit County Jail Storage Building Project, in an amount not to exceed \$117,000.00, for the County Executive's Department of Administrative Services-Physical Plants, and declaring an emergency.

WHEREAS, after receipt of bids, the County Executive's Department of Administrative Services-Physical Plants selected Krumroy-Cozad Construction, Inc. as the most responsive and responsible bidder; and

WHEREAS, the Board of Control, at its meeting held on June 24, 2020, awarded a construction contract with Krumroy-Cozad Construction, Inc. for the Summit County Jail Storage Building Project, in an amount not to exceed \$117,000.00, subject to confirmation by County Council; and

WHEREAS, the initial construction estimate of \$85,000.00 did not include additional interior drywall and insulation for the storage facility as well as additional labor costs necessary due to the slope of the building site, all of which were identified and added to the bid specs prior to release of the bid; and
