7 **A Resolution authorizing the County Executive to execute a Cooperative Agreement with**
8 **the City of Hudson concerning the proposed multi-purpose trail to be constructed along the**
9 **Valley View Road Bridge over Brandywine Creek, located in City of Hudson, Council**
10 **District 1, for the County Engineer, and declaring an emergency.**

11
12 WHEREAS, Valley View Road (a.k.a. County Highway 25) extends within the City of
13 Hudson from the Northern Corporation line to State Route 91, Darrow Road crossing over
14 Brandywine Creek at Bridge No. HUT-025-1083, a county owned and maintained structure; and

15
16 WHEREAS, the City of Hudson desires to construct a new multi-purpose trail (the
17 “Project”) along this portion of Valley View Road; and

18
19 WHEREAS, the City of Hudson desires to construct a reinforced concrete barrier wall
20 between the trail and the edge of the bridge as it crosses over Brandywine Creek; and

21
22 WHEREAS, the Project will positively impact both pedestrian, bicycle and vehicular
23 traffic crossing the bridge; and

24
25 WHEREAS, it is necessary for the parties to execute a Cooperative Agreement to set
26 forth the rights and duties of the parties concerning the design, construction, and maintenance of
27 the Project; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that it is necessary and in the best interest of the County of Summit to authorize the County
31 Executive to execute the aforementioned Cooperative Agreement with the City of Hudson for the
32 Project;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
35 of Ohio, that;

37 SECTION 1

39 The County Executive is hereby authorized to execute a Cooperative Agreement and any
40 other necessary related documents with the City of Hudson for the proposed multi-purpose trail
41 to be constructed along the Valley View Road Bridge over Brandywine Creek, a copy of which
42 is attached hereto as Exhibit A and incorporated fully herein, with such modifications and
43 revisions as shall be in furtherance of the provisions of said Cooperative Agreement and not
44 substantially adverse to the County, all of which shall be conclusively evidenced by the
45 execution thereof by the County Executive.

49 This Resolution is hereby declared an emergency in the interest of the health, safety and
50 welfare of the residents of the County of Summit, and for the further purpose to immediately

8 travel of pedestrians and cyclists in the City of Hudson.

12 Provided this Resolution receives the affirmative vote of eight members, it shall take
13 effect immediately upon its adoption and approval by the County Executive; otherwise, it shall
14 take effect and be in force at the earliest time provided by law.

19 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
20 deliberations of this Council and of any of its committees that resulted in such formal action,
