WHEREAS, this Council finds and determines, after reviewing all pertinent information that the aforementioned professional service contracts with certain providers set forth in Exhibit A are necessary and in the best interest of the County of Summit;
NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
SECTION 1
The award by the Board of Control of professional service contracts with certain providers, as set forth in Exhibit A, attached to this Resolution and incorporated herein by reference, for the State Fiscal Year 2021 Temporary Assistance to Needy Families ("TANF") funded services, from 10/1/20 through 9/30/21, in a total amount not to exceed \$1,865,600.00,

racts with certain porated herein by r amilies ("TANF") ed \$1,865,600.00, are hereby confirmed and the Executive is hereby authorized to execute such professional service contracts and any other necessary related documents.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit, and for the further reason to immediately authorize the Executive to execute the aforementioned professional service contracts in order to enable to providers to provide necessary services as expeditiously as possible.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
