Shelter Care	<p>Safe Landing Youth Shelters serve both boys and girls and provide short-term crisis residential care. Stay ranges from few hours to three weeks.</p>	\$100,000.00
Summit County Cluster for Youth	<p>Cluster is composed of Juvenile Court, CSB, MRDD, ADM, and ODYS. Agencies pool resources in order to secure residential placements for children involved with multiple agencies. Children may or may not remain in the custody of a parent during placement.</p>	\$131,084.00
Shelter Care	<p>Youth Assessment Program provides a group home setting for up to 90 days for children charged with or adjudicated on a sexual offense.</p>	\$98,550.00
Various	<p>Long term placements provide a wide range of services and care for troubled youth when it is contrary to their best interests to remain in their home. Children can be placed in either open and locked settings. Service covers a variety of issues depending on child's needs. Most placements last anywhere from 9-16 months.</p>	\$300,000.00
