7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract with Greenleaf Family Center to provide assessments to identify individuals who**  
9 **may require enhanced Court services through the Summit County Targeted Community**  
10 **Alternatives to Prison plan, for a one-year term, from 7/1/20 through 6/30/21, in an amount**  
11 **not to exceed \$153,800.00, for the Executive's Department of Law and Risk Management –**  
12 **Division of Public Safety, and declaring an emergency.**

13  
14 WHEREAS, the Summit County Targeted Community Alternatives to Prison Plan (the  
15 "Plan") was developed to assist in maintaining most felony offenders locally, as well as  
16 providing additional programming and supervision for other low level offenders who may be  
17 displaced by a felony offender who is sentenced to the Jail; and

18  
19 WHEREAS, a part of the Plan is to provide assessments for the Common Pleas Court to  
20 help with early identification of individuals who may require enhanced services through a  
21 specialized docket which would expedite programs and services for these individuals in lieu of  
22 incarceration; and

23  
24 WHEREAS, the Greenleaf Family Center already provides similar assessment services to  
25 the Court of Common Pleas, and the Executive wishes to enter into a professional service  
26 contract with the Greenleaf Family Center to provide said programs and services to individuals  
27 pursuant to the Plan; and

29 WHEREAS, the Board of Control, at its meeting held July 29, 2020, awarded a  
30 professional service contract with Greenleaf Family Center to provide assessments to identify  
31 individuals who may require enhanced Court services through the Plan, for a one-year term, from  
32 7/1/20 through 6/30/21, in an amount not to exceed \$153,800.00, subject to confirmation by this  
33 Council; and

35 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
36 that the aforementioned professional service contract with Greenleaf Family Center is necessary  
37 and in the best interest of the County of Summit;

39 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
40 of Ohio, that:

44 The award by the Board of Control of a professional service contract with Greenleaf  
45 Family Center to provide assessments to identify individuals who may require enhanced Court  
46 services through the Summit County Targeted Community Alternatives to Prison Plan (the  
47 "Plan"), for the term 7/1/20 through 6/30/21, in an amount not to exceed \$153,800.00, is hereby  
48 confirmed and the Executive is hereby authorized to execute said professional service contract  
49 and any other necessary related documents.

10 SECTION 3




