7 **A Resolution authorizing the Executive to execute an intergovernmental agreement with**  
8 **the Summit County Combined General Health District dba Summit County Public Health,**  
9 **to increase utilization of Healthchek Early, Periodic, Screening, Diagnostic and Testing**  
10 **services for young children, for a one-year term, from 10/1/20 to 9/30/21, in an amount not**  
11 **to exceed \$120,000.00, for the Executive's Department of Job and Family Services, and**  
12 **declaring an emergency.**

13  
14 WHEREAS, the Executive wishes to enter into an intergovernmental agreement with the  
15 Summit County Combined General Health District dba Summit County Public Health, to  
16 increase utilization of Healthchek Early, Periodic, Screening, Diagnostic and Testing services for  
17 young children, for a one-year term, from 10/1/20 to 9/30/21, in an amount not to exceed  
18 \$120,000.00; and

20 WHEREAS, services provided by Summit County Public Health will include outreach to  
21 educate families about the importance of timely screenings and Healthchek services (such as  
22 Help Me Grow, Infant Mortality prevention, and WIC services) to help families understand care,  
23 safety and developmental needs of young children; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
26 that the aforementioned intergovernmental agreement with the Summit County Public Health is  
27 necessary and in the best interest of the County of Summit;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
30 of Ohio, that;

32 SECTION 1

34 The Executive is hereby authorized to execute an intergovernmental agreement with the  
35 Summit County Combined General Health District dba Summit County Public Health to increase  
36 utilization of Healthchek Early, Periodic, Screening, Diagnostic and Testing services for young  
37 children, for a one-year term, from 10/1/20 to 9/30/21, in an amount not to exceed \$120,000.00.

41 This Resolution is hereby declared an emergency in the interest of the health, safety, and  
42 welfare of the residents of the County of Summit and for the further reason of immediately  
43 providing necessary services for the Executive's Department of Job and Family Services  
44 effective 10/1/20.

48 Provided this Resolution receives the affirmative vote of eight members, it shall take  
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
50 effect and be in force at the earliest time provided by law.
