7 **A Resolution confirming the award by the Board of Control of a purchase contract with**
8 **Farrwest Environmental Supply, Inc. for the purchase of a handheld chemical analyzer for**
9 **the Summit County Type I Hazardous Materials Response Team, in an amount not to**
10 **exceed \$92,000.00, for the Executive's Department of Law and Risk Management-Division**
11 **of Public Safety, Emergency Management Agency, and declaring an emergency.**

13 WHEREAS, this Council previously adopted Resolution No. 2020-208, which authorized
14 the Executive to advertise for bids for a handheld chemical analyzer for the Summit County
15 Type I Hazardous Materials Response Team, for an estimated total cost not to exceed
16 \$105,000.00; and

18 WHEREAS, after reviewing bids, the Executive selected Farrwest Environmental
19 Supply, Inc. as the lowest responsive and responsible bidder; and

21 WHEREAS, the Board of Control, at its September 16, 2020 meeting, awarded a purchase
22 contract with Farrwest Environmental Supply, Inc. for the purchase of a handheld chemical
23 analyzer for the Summit County Type I Hazardous Materials Response Team, for an amount not
24 to exceed \$92,000.00, subject to confirmation by this Council; and

26 WHEREAS, said equipment will be fully grant-funded; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that the aforementioned purchase contract with Farrwest Environmental Supply, Inc., is
30 necessary and in the best interest of the County of Summit;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

37 The award by the Board of Control of a purchase contract with Farrwest Environmental
38 Supply, Inc. for the purchase of a handheld chemical analyzer for the Summit County Type I
39 Hazardous Materials Response Team, in an amount not to exceed \$92,000.00, is hereby
40 confirmed and the Executive is hereby authorized to execute said purchase contract and any
41 other necessary related documents.

45 This Resolution is declared an emergency in the interest of the health, safety, and welfare
46 of the residents of the County of Summit, and for the further reason that it authorizes the
47 procurement of necessary equipment within the grant performance period.


