7 **A Resolution establishing an Ad Hoc Committee to review the Summit County Sheriff's**
8 **foreclosure appraisal process, for the County Council, and declaring an emergency.**

10 WHEREAS, for purposes of economy, efficiency, fairness and transparency it is
11 necessary to examine the Sheriff's foreclosure appraisal process for possible changes; and

12

13 WHEREAS, the chair and members of the Rules Committee, shall invite representatives
14 of the Sheriff's office, clerk of courts, prosecutor and fiscal office and others as needed, to meet
15 and share information on how to make the Sheriff's foreclosure appraisal process more
16 economical, efficient, fair and transparent for the taxpayers of Summit County; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that it is necessary and in the best interest of the County of Summit to establish an Ad Hoc
20 Committee to review the Summit County Sheriff's foreclosure appraisal process;

22 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
23 of Ohio, that:

25 SECTION 1

27 The County Council will hereby establish an Ad Hoc Committee to review the Summit
28 County Sheriff's foreclosure appraisal process and recommend possible changes.

30 SECTION 2

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the residents of the County of Summit and for the further reason of establishing an Ad
34 Hoc Committee to review the Summit County Sheriff's foreclosure appraisal process.

36 SECTION 3

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.

42 SECTION 4

44 It is found and determined that all formal actions of this Council concerning and relating
45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
46 deliberations of this Council and of any of its committees that resulted in such formal action,
47 were in meetings open to the public, in compliance with all legal requirements, including Section
48 121.22 of the Ohio Revised Code.
