7 **A Resolution authorizing the Executive to execute an Ohio Public Works Commission**
8 **grant application and any other documents necessary to apply for and accept Local**
9 **Transportation Improvement Program grant funds, in the amount of \$373,500.00, with no**
10 **local cash match requirement, for the resurfacing of Canton Road from Tisen Road to**
11 **Salmon Drive in Springfield Township, in District 8, for the Engineer, and declaring an**
12 **emergency.**

13
14 WHEREAS, the Engineer concludes that there is a public need for the resurfacing of
15 Canton Road from Tisen Road to Salmon Drive in Springfield Township, in County Council
16 District 8; and

17
18 WHEREAS, the County of Summit is eligible to acquire Ohio Public Works Commission
19 Local Transportation Improvement Program ("LTIP") grant funds, in the amount of \$373,500.00
20 for the resurfacing of Canton Road, with no amount necessary for local matching County road
21 and bridge funds; and

23 WHEREAS, the Ohio Public Works Commission requires local authorizing legislation as
24 part of the application for LTIP grant funds; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
28 execute an Ohio Public Works Commission grant application and any other documents necessary
29 to accept and administer LTIP grant funds for the aforementioned purpose;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
32 of Ohio, that:

36 The Executive is hereby authorized to execute an Ohio Public Works grant application
37 and any other documents necessary to accept and administer a grant for Ohio Public Works
38 Commission Local Transportation Improvement Program ("LTIP") funds, in an amount not to
39 exceed \$373,500.00, for the purpose of resurfacing Canton Road from Tisen Road to Salmon
40 Drive, in Springfield Township, in Council District 8 (the "Project").

44 The Clerk of Council is instructed to provide two certified copies of this Resolution to the
45 Engineer, for submission to the Ohio Public Works Commission with said grant application.

7 welfare of the residents of the County of Summit, and for the further reason that it will allow the
8 County to obtain LTIP grant funds for an immediately needed resurfacing project.

12 Provided this Resolution receives the affirmative vote of eight members, it shall take
13 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
14 effect and be in force at the earliest time provided by law.

19 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
20 deliberations of this Council and of any of its committees that resulted in such formal action,
