This Council hereby authorizes the Executive to execute a Sublease Agreement with the City of Akron, for the lease of approximately 8,840 square feet of space in the Pry Building, located at 1180 S. Main Street, Akron, Ohio 44301, in Council District 5, to be used for the City of Akron's Utilities Business Office, for a term of five (5) years, with one renewal option for five (5) years, which is attached hereto as Exhibit A and incorporated herein as if fully restated, and any necessary modifications or amendments thereto, upon terms substantially similar to and not materially adverse to the County and to execute any other documents necessary to effectuate the Sublease Agreement.

## **SECTION 2**

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit and for the further purpose of immediately allowing the space in the Pry Building to be used for the City of Akron's Utilities Business Office as provided in the Sublease Agreement so that it may be returned to productive use as soon as possible.

## **SECTION 3**

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
