7 **A Resolution confirming the award of a purchase contract with Locus Diagnostics, LLC, as**  
8 **a Sole Source, for an over the air waveform analyzer to remotely identify radios which**  
9 **require servicing, in an amount not to exceed \$61,942.92, for the Executive's Department of**  
10 **Law and Risk Management-Division of Public Safety, Emergency Management Agency,**  
11 **and declaring an emergency.**

12  
13 WHEREAS, approximately 6,000 radios used by the Executive's Department of Law and  
14 Risk Management-Division of Public Safety, Emergency Management Agency ("EMA")  
15 including County owned radios as well as those owned by the communities that are part of the  
16 EMA system periodically require servicing; and

17  
18 WHEREAS, EMA used an over the air waveform analyzer manufactured by Locus  
19 Diagnostics, LLC, for a period of one week, and determined remotely that 30 radio units required  
20 service; and

21  
22 WHEREAS, EMA wishes to enter into a purchase contract with Locus Diagnostics, LLC,  
23 the Sole Source for the over the air wave form analyzer, which will benefit public safety users in  
24 the long-term by assuring that their radio equipment is operating correctly; and

26 WHEREAS, the Board of Control, at its October 14, 2020 meeting, awarded a purchase  
27 contract with Locus Diagnostics, LLC, a Sole Source, for an over the air waveform analyzer to  
28 remotely identify radios which require servicing, in an amount not to exceed \$61,942.92, subject  
29 to confirmation by this Council; and

30  
31 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
32 that the aforementioned purchase contract with Locus Diagnostics, LLC is necessary and in the  
33 best interest of the County of Summit;

35 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
36 of Ohio, that:

40 The award by the Board of Control of a purchase contract with Locus Diagnostics, LLC,  
41 as a Sole Source, for an over the air waveform analyzer to remotely identify radios which require  
42 servicing, in an amount not to exceed \$61,942.92, is hereby confirmed and the Executive is  
43 hereby authorized to execute said purchase contract and any other necessary related documents.

47 This Resolution is hereby declared an emergency in the interest of the health, safety, and  
48 welfare of the residents of the County of Summit, and for the further reason to immediately  
49 authorize the purchase of necessary equipment to ensure that radios used by public safety  
50 personnel are operating correctly.
