7 **A Resolution authorizing the Executive to advertise for bids for the purchase of a Tri-Axle**
8 **Dump Trailer, for an amount not to exceed \$70,000.00, for the Executive's Department of**
9 **Sanitary Sewer Services, and declaring an emergency.**

11 WHEREAS, the Executive wishes to advertise for bids for the purchase of a Tri-Axle
12 Dump Trailer, for an amount not to exceed \$70,000.00; and

13
14 WHEREAS, a Tri-Axle Dump Trailer is a critical piece of equipment for the Department
15 of Sanitary Sewer Services and is utilized for the daily operations of the Department; and

16
17 WHEREAS, the Tri-Axle Dump Trailer will be utilized for the hauling of sludge and for
18 the transport of materials and other purposes during sewer mainline repairs and rehabilitation;
19 and

21 WHEREAS, the previous dump trailer was at the end of its service life and was
22 decommissioned for safety reasons; and

23
24 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
25 requires this Council's authorization for the Executive to advertise for bids that exceed
26 \$50,000.00; and

28 WHEREAS, a copy of the bid specifications is attached herein as Exhibit A and
29 incorporated hereto as if fully rewritten; and

31 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
32 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
33 advertise for bids for the aforementioned purchase of the Tri-Axle Dump trailer, for an amount
34 not to exceed \$70,000.00;

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
37 of Ohio, that:

41 The Executive is hereby authorized to advertise for bids for the purchase of a Tri-Axle
42 Dump Trailer for the Department of Sanitary Sewer Services to be utilized for the Department's
43 daily operations throughout the County, for an amount not to exceed \$70,000.00.

47 This Resolution is hereby declared an emergency in the interest of the health, safety and
48 welfare of the residents of the County of Summit, and for the further reason that it authorizes the
49 Executive to immediately advertise for bids for the purchase of a necessary trailer for the
50 Department of Sanitary Sewer Services.
