7 **A Resolution confirming the award by the Board of Control of a purchase contract with**
8 **Jordan Services LLC, for the cleaning, videotaping and mapping of storm sewers, in an**
9 **amount not to exceed \$122,850.00, for the Engineer and declaring an emergency.**

11 WHEREAS, the Engineer started an annual storm sewer cleaning and videotaping
12 program in 2017; and

13
14 WHEREAS, this Council previously adopted Resolution No. 2020-027, which approved
15 the 2020-2025 Capital Improvements Program, which includes the Cleveland-Massillon Road at
16 Ridgewood Road Intersection Improvement Project, located in Copley Township, in Council
17 District 5, the West Bath Road Landslide Mitigation Project, located in Bath Township, in
18 Council District 4, and the 2020 Storm Sewer Cleaning and Videotaping Program, located
19 throughout the County, for the Engineer; and

21 WHEREAS, this Council subsequently adopted Resolution No. 2020-045, which
22 authorized the Executive to advertise for bids for the Cleveland-Massillon Road at Ridgewood
23 Road Intersection Improvement, the West Bath Road Landslide Mitigation Project, and the 2020
24 Storm Sewer Cleaning and Videotaping Program, at an estimated cost not to exceed
25 \$2,362,000.00; and

27 WHEREAS, pursuant to Resolution No. 2020-045, the Executive was authorized to
28 advertise for bids 2020 Storm Sewer Cleaning and Videotaping Program for an amount not to
29 exceed \$250,000.00; and

30
31 WHEREAS, the Engineer sent five bid packages out and received two bids, of which
32 only the bid from Jordan Services, LLC, in the amount of \$122,850.00 was responsive and
33 responsible; and

35 WHEREAS, the Board of Control, at its meeting held November 18, 2020, awarded a
36 purchase contract with Jordan Services LLC, for the cleaning, videotaping and mapping of storm
37 sewers, in an amount not to exceed \$122,850.00, subject to confirmation by this Council; and

39 WHEREAS, this Council finds and determines, after reviewing all pertinent information
40 that the aforementioned purchase contract with Jordan Services, LLC is necessary and in the best
41 interest of the County of Summit;

43 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
44 of Ohio, that;

6 The award by the Board of Control of purchase contract with Jordan Services LLC, for
7 the cleaning, videotaping and mapping of storm sewers, in an amount not to exceed \$122,850.00,
8 is hereby confirmed and the Executive is hereby authorized to execute said purchase contract and
9 any other necessary related documents.

13 This Resolution is declared an emergency in the interest of the health, safety, and welfare
14 of the residents of the County of Summit, and for the further reason that it immediately provides
15 for the cleaning, videotaping and mapping of storm sewers.

19 Provided this resolution receives the affirmative vote of eight members, it shall take
20 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
21 effect and be in force at the earliest time provided by law.

25 It is found and determined that all formal actions of this Council concerning and relating
26 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
27 deliberations of this Council and any of its committees that resulted in such formal action, were

29 121.22 of the Ohio Revised Code.
