7 **A Resolution authorizing the County Executive to advertise for bids for the Edwin Shaw**
8 **Demolition Project, for an estimated total cost not to exceed \$1,600,000.00, for the**
9 **Executive's Department of Administrative Services – Physical Plants, and declaring an**
10 **emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
13 requires this Council's authorization for the County Executive to advertise for bids; and

15 WHEREAS, the County Executive wishes to advertise for bids for the Edwin Shaw
16 Demolition Project in Council District 8; and

18 WHEREAS, a copy of the bid specifications are on file in the office of the Clerk of
19 Council; and

21 WHEREAS this Council finds and determines, after reviewing all pertinent information
22 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
23 advertise for bids for the aforementioned project.

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
26 of Ohio, that:

30 The County Executive is authorized to advertise for bids for the Edwin Shaw Demolition
31 Project, in Council District 8, for an estimated total cost not to exceed \$1,600,000.00

33 SECTION 2

35 This Resolution is hereby declared an emergency in the interest of the health, safety and
36 welfare of the citizens of the County of Summit, and for the further reason that it authorizes the
37 Executive to immediately advertise for bids in order to demolish the dilapidated buildings on the
38 Edwin Shaw property.

42 Provided this Resolution receives the affirmative vote of eight members, it shall take
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
44 effect and be in force at the earliest time provided by law.

48 It is found and determined that all formal actions of this Council concerning and relating
49 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
50 deliberations of this Council and of any of its committees that resulted in such formal action,
51 were in meetings open to the public, in compliance with all legal requirements, including Section
52 121.22 of the Ohio Revised Code.




