7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **agreement with Motorola Solutions, Inc., for the 800 MHz Regional Radio System, for the**  
9 **period 1/1/16 through 12/31/16, as a Best Practical Source in an amount not to exceed**  
10 **\$104,886.77, for the Executive's Department of Law, Insurance and Risk Management,**  
11 **Division of Public Safety, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held December 16, 2015, awarded a  
14 professional service agreement with Motorola Solutions, Inc., for the 800 MHz Regional Radio  
15 System, for the period 1/1/16 through 12/31/16, as a Best Practical Source, subject to  
16 confirmation by County Council; and

18 WHEREAS, this Council finds and determines, by reviewing all pertinent information,  
19 that the aforementioned professional service agreement with Motorola Solutions, Inc. is  
20 necessary and in the best interest of the County of Summit; and

22 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
23 of Ohio, that:

27 The award by Board of Control of a professional service agreement with Motorola  
28 Solutions, Inc., for the 800 MHz Regional Radio System, for the period 1/1/16 through 12/31/16,  
29 as a Best Practical Source, in an amount not to exceed \$104,886.77, is hereby confirmed and the  
30 County Executive is hereby authorized to execute such agreement.

34 This Resolution is declared an emergency in the interest of the health, safety and welfare  
35 of the citizens of the County of Summit and for the further purpose of immediately providing the  
36 necessary agreement for the 800 MHz Regional Radio System effective 1/1/16.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take  
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
42 effect and be in force at the earliest time provided by law.

46 It is found and determined that all formal actions of this Council concerning and relating  
47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
48 deliberations of this Council and of any of its committees that resulted in such formal action,

50 121.22 of the Ohio Revised Code.


