12 WHEREAS, the Board of Control, at its meeting held February 3, 2016 awarded a
13 purchase contract to Calcium Chloride Sales for calcium chloride materials for the 2016 snow
14 and ice control season, under CUE pricing, in an amount not to exceed \$60,000.00, subject to
15 confirmation by County Council; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that the aforementioned purchase contract with Calcium Chloride Sales is necessary and in the
19 best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

27 for calcium chloride materials for the 2016 snow and ice control season, under CUE pricing, in
28 an amount not to exceed \$60,000.00, is hereby confirmed and the County Executive is hereby
29 authorized to execute such purchase contract.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide for calcium chloride materials for the 2016 snow and ice control season.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.
