7 **A Resolution authorizing the County Executive to advertise for bids for the purchase of**
8 **two Utility Construction Service Bodies and a truck mounted service crane to be installed**
9 **on a 2015 Ford F-550 and a 2016 Ford F-550, for an estimated cost not to exceed**
10 **\$76,514.00, for the Executive's Department of Sanitary Sewer Services, and declaring an**
11 **emergency.**

13 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
14 requires this Council's authorization for the County Executive to advertise for bids; and

15
16 WHEREAS, the County Executive wishes to advertise for bids for the purchase of two
17 Utility Construction Service Bodies and a truck mounted service crane to be installed on a 2015
18 Ford F-550 and a 2016 Ford F-550, for an estimated cost not to exceed \$76,514.00, for the
19 Executive's Department of Sanitary Sewer Services; and

21 WHEREAS, a copy of the bid specifications are attached as Exhibit A; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
25 advertise for bids for the purchase of two Utility Construction Service Bodies and a truck
26 mounted service crane to be installed on a 2015 Ford F-550 and a 2016 Ford F-550, for an
27 estimated total not to exceed \$76,514.00;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

34 The County Executive is authorized to advertise for bids for two Utility Construction
35 Service Bodies and a truck mounted service crane to be installed on a 2015 Ford F-550 and a
36 2016 Ford F-550, for an estimated total amount not to exceed \$76,514.00, for the Executive's
37 Department of Sanitary Sewer Services.

41 This Resolution is declared an emergency in the interest of the health, safety, and welfare
42 of the citizens of the County of Summit, and for the further reason that it authorizes the
43 Executive to immediately advertise for bids for two Utility Construction Service Bodies and a
44 truck mounted service crane, for an estimated cost not to exceed \$76,514.00, for the Executive's
45 Department of Sanitary Sewer Services.

50 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
51 effect and be in force at the earliest time provided by law.
