A Resolution authorizing the County Executive to execute a contract with the Ohio & Erie Canal Corridor Coalition, Inc. dba Ohio & Erie Canalway Coalition, for a grant, in an amount not to exceed \$35,000.00, for Canal Corridor Development and Trail Planning in the form of grants to various communities in partnership with the Coalition, for the Executive's Department of Finance and Budget, and declaring an emergency.
WHEREAS, pending before this Council is Resolution No. 2016-042, which adopts the Capital Improvements Program for 2016-2021 for the County of Summit and appropriates funds, in the amount of \$7,566,358.00, for the balance of projects in the 2016 Capital Improvement Plan; and
WHEREAS, as part of the 2016 Capital Improvements Program Budget, Resolution No. 2016-042 appropriates funds in Account No. 40010-820501-78501, in the amount of \$35,000.00, for a grant to the Ohio & Erie Canal Corridor Coalition, Inc. dba Ohio & Erie Canalway Coalition, an Ohio nonprofit corporation (the "Coalition"), for Canal Corridor Development and Trail Planning, which will be in the form of grants to various communities in partnership with the Coalition in 2016; and
WHEREAS, the County of Summit is committed to working to preserve and develop the Ohio and Erie Canal National Heritage Corridor; and
WHEREAS, the County wishes to provide a grant to the Coalition, in an amount not to exceed \$35,000.00, for Canal Corridor Development and Trail Planning in the form of grants to various communities in partnership with the Coalition in 2016; and
WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute a contract with the Coalition for said grant for the aforementioned reasons;
NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
SECTION 1
The County Executive is hereby authorized to execute a contract with the Ohio & Erie Canal Corridor Coalition, Inc. dba Ohio & Erie Canalway Coalition (the "Coalition") for a grant, in an amount not to exceed \$35,000.00, for Canal Corridor Development and Trail Planning in the form of grants to various communities in partnership with the Coalition in 2016. Said grant will be paid out of Capital Improvements Funds, Account No. 40010-820501-78501.

This Resolution is hereby declared an emergency in the interest of the health, safety and

welfare of the citizens of the County of Summit, and for the further reason to immediately provide a grant to the Coalition for Canal Corridor Development and Trail Planning in the form

of grants to various communities in partnership with the Coalition in 2016.
