7 **A Resolution confirming an award of a renewal (second and final) by the Board of Control**  
8 **of a professional service contract with Quality Control Inspection, Inc., as a Best Practical**  
9 **Source, for construction inspection services, for the period of 1/1/16 to 12/31/16, in an**  
10 **amount not to exceed \$100,000.00, for the Engineer, and declaring an emergency.**

12 WHEREAS, this Council previously adopted Resolution No. 2014-082 which confirmed  
13 an award by the Board of Control of a professional service contract with Quality Service  
14 Inspection, Inc., as a Best Practical Source, for construction services, for the period of 1/1/14 to  
15 12/31/14, with two options to renew for a one-year period, in an amount not to exceed  
16 \$100,000.00; and

18 WHEREAS, this Council previously adopted Resolution No. 2015-092, confirmed a  
19 renewal of a professional service contract (first of two) with Quality Service Inspection, Inc., as a  
20 Best Practical Source, for construction services, for the period of 1/1/15 to 12/31/15, in an  
21 amount not to exceed \$100,000.00; and

23 WHEREAS, the Board of Control, at its meeting held on February 10, 2016, awarded a  
24 renewal (second and final) of a professional service contract with Quality Service Inspection,  
25 Inc., as a Best Practical Source, for construction services, for the period of 1/1/16 to 12/31/16, in  
26 an amount not to exceed \$100,000.00; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
29 that the aforementioned renewal of a professional service contract with Quality Control  
30 Inspection, Inc. is necessary and in the best interest of the County of Summit;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
33 of Ohio, that:

37 The award by the Board of Control of a renewal (second and final) of a professional  
38 service contract with Quality Control Inspection, Inc., as a Best Practical Source, for  
39 construction inspection services, for the period of 1/1/16 to 12/31/16, in an amount not to exceed  
40 \$100,000.00 is hereby confirmed and the County Executive is hereby authorized to execute such  
41 renewal of said professional service contract.

45 This Resolution is hereby declared an emergency in the interest of the health, safety and  
46 welfare of the citizens of the County of Summit, and for the further reason to immediately  
47 provide for the renewal of a professional service contract with Quality Control Inspection, Inc.,
