7 **A Resolution appropriating continuing professional training reimbursement funds**
8 **received from the Ohio Attorney General’s Office, in the amount of \$35,000.00, through**
9 **12/31/2016, for the Sheriff’s Office and declaring an emergency.**

11 WHEREAS, Section 109.803 of the Ohio Revised Code requires appointed peace
12 officers and troopers to complete up to twenty-four hours of continuing professional training
13 each calendar year; and

14
15 WHEREAS, Section 109.802 of the Ohio Revised Code provides for a formula
16 reimbursement of continuing professional training costs through the Ohio Attorney General’s
17 Office; and

18
19 WHEREAS, the Ohio Attorney General’s Office has issued a payment in the amount of
20 \$34,160.00 to the Sheriff’s office as reimbursement for training costs, and the fund balance
21 prior to receiving this check was \$17,337.36, bringing the cash balance in the fund to
22 \$51,497.36; and

24 WHEREAS, the Sheriff’s Office requests that \$35,000.00 in continuing professional
25 training funds be appropriated for training and equipment expenses related to continuing
26 professional training; and

28 WHEREAS, this Council has determined by reviewing all pertinent information that it is
29 necessary and in the best interest of the County of Summit to appropriate the aforementioned
30 continuing professional training reimbursement funds received from the Ohio Attorney
31 General’s Office, in the amount of \$35,000.00;


