7 **A Resolution designating the Executive's Department of Job and Family Services as the**  
8 **lead agency to oversee the administration of the Comprehensive Case Management and**  
9 **Employment Program, for the Executive's Department of Job and Family Services, and**  
10 **declaring an emergency.**

11  
12 WHEREAS, Section 305.190 of the Amended Substitute House Bill 64 of the 131st  
13 General Assembly, the state's biennial budget, creates the Comprehensive Case Management  
14 Employment Program, to provide employment, training and other supportive services to  
15 mandatory and voluntary program participants ages 16 to 24 based upon a comprehensive  
16 assessment of an individual's employment and training needs; and

17  
18 WHEREAS, each County is required by Section 305.190 no later than May 15, 2016 to  
19 designate either the county department of job and family services or the workforce development  
20 agency that serves the county as the lead agency responsible for administering the program and  
21 meeting performance goals established by the State; and

23 WHEREAS, the effective date for the implementation of the Comprehensive Case  
24 Management Employment Program shall be July 1, 2016; and

26 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
27 necessary and in the best interest of the County of Summit to designate the Department of Job  
28 and Family Services as the lead agency to oversee the administration of the Comprehensive Case  
29 Management and Employment Program;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
32 of Ohio, that:

34 SECTION 1

36 The Executive's Department of Job and Family Services is hereby designated as the lead  
37 agency to oversee the administration of the Comprehensive Case Management and Employment  
38 Program.

40 SECTION 2

42 This Resolution is hereby declared an emergency in the interest of the health, safety and  
43 welfare of the citizens of the County of Summit and for the further purpose of timely designating  
44 the County's lead agency for the Comprehensive Case Management and Employment Program  
45 before a recommended March 1, 2016 deadline in order to administer the program beginning  
46 July 1, 2016.

50 Provided this Resolution receives the affirmative vote of eight members, it shall take  
51 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
52 effect and be in force at the earliest time provided by law.
