7 **A Resolution authorizing the County of Summit to participate in Ohiocheckbook.com, a**
8 **website run by the Ohio Treasurer providing information to the public about state and**
9 **local spending, for the Fiscal Officer, and declaring an emergency.**

11 WHEREAS, OhioCheckbook.com is a website launched recently by the office of Ohio
12 Treasurer Josh Mandel, which site allows Ohioans to search and share state spending; and

13
14 WHEREAS, Treasurer Mandel is seeking local government partnership to further
15 facilitate transparency and is asking for participation at the county level; and

16
17 WHEREAS, eleven Ohio counties are currently participating in Ohiocheckbook.com,
18 including the counties of Mahoning, Franklin, Lorain, Lucas and Hamilton; and

20 WHEREAS, the State of Ohio will host, post and display County of Summit spending at
21 no cost to the County; and

23 WHEREAS, the County of Summit wishes to participate in Ohiocheckbook.com; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that it is necessary and in the best interest of the County of Summit to authorize the County of
27 Summit to participate in Ohiocheckbook.com;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
30 of Ohio, that;

34 The County of Summit is hereby authorized to participate in Ohiocheckbook.com, a
35 website run by the Ohio Treasurer providing information to the public about state and local
36 spending.

40 This Resolution is declared an emergency in the interest of the health, safety, and welfare
41 of the citizens of the County of Summit, and for the further reason that it immediately authorizes
42 the County of Summit to participate in Ohiocheckbook.com.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
48 effect and be in force at the earliest time provided by law.


