7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award from the Ohio Department of Job and Family Services of a 2016 Summer**
9 **Youth Employment Program grant of Temporary Assistance for Needy Families funds, for**
10 **the period 5/1/16 through 8/31/16, in the amount of \$1,960,706.00, with no local cash match**
11 **requirement, and appropriating grant funds, for the Executive’s Department of Job and**
12 **Family Services, and declaring an emergency.**

14 WHEREAS, the County Executive’s Department of Job and Family Services (“SCJFS”)
15 has received an award of federal funds from the Ohio Department of Job and Family Services
16 (“ODJFS”) for a 2016 Summer Youth Employment Program grant of Temporary Assistance for
17 Needy Families (“TANF”) funds, in the amount of \$1,960,706.00, with no local cash match
18 requirement; and

20 WHEREAS, this TANF funding will support the 2016 TANF Summer Youth
21 Employment Program which will operate from 5/1/16 through 8/31/16; and

23 WHEREAS, the 2016 TANF Summer Youth Employment Program will provide low
24 income TANF-eligible youths the opportunity to gain valuable work experience while earning a
25 paycheck; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
28 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
29 immediately execute any documents necessary to accept the award of the aforementioned grant
30 from ODJFS, and to appropriate these grant funds;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

37 The County Executive is hereby authorized to execute any documents necessary to accept
38 the award of a 2016 TANF Summer Youth Employment Program grant from the Ohio
39 Department of Job and Family Services (“ODJFS”), for the period 5/1/16 through 8/31/16, in the
40 amount of \$1,960,706.00, with no local cash match requirement.

29 121.22 of the Ohio Revised Code.


