8 **contract with Kronos, Inc., as a Sole Source, to provide software support services,**

11 **of Information Technology, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held April 6, 2016, awarded a
14 professional service contract to Kronos, Inc., as a Sole Source, to provide software support
15 services, equipment support services and education services for the County's payroll system, for
16 the period of 3/21/16 through 3/20/17, in an amount not to exceed \$86,981.02, approved by the
17 IT Board on 3/30/16, subject to confirmation by County Council; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
20 the aforementioned professional service contract with Kronos, Inc. is necessary and in the best
21 interest of the County of Summit;

23 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

28 The award by the Board of Control of a professional service contract with Kronos, Inc.,
29 as a Sole Source, to provide software support services, equipment support services and education
30 services for the County's payroll system, for the period of 3/21/16 through 3/20/17, approved by
31 the IT Board on 3/30/16 in an amount not to exceed \$86,981.02, is hereby confirmed and the
32 County Executive is hereby authorized to execute said contract.

36 This Resolution is hereby declared an emergency in the interest of the health, safety, and
37 welfare of the citizens of the County of Summit, and for the further reason to immediately
38 provide software support services, equipment support services, and educational services for the
39 County's payroll system effective 3/21/16.

44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
45 effect and be in force at the earliest time provided by law.
